Lavon Brown (12/26/1965 TX SID 05411277 TX DL 22116909 TCSO CID 0245988) on November 8, 2022, at 9:40 pm. Brown came into the Tarrant County Jail on September 6, 2022, at 4:15 pm on an Abandoning or Endangering a Child with Intent to Return charge originating from the Fort Worth Police Department. The charge is filed with the Tarrant County District Attorney and assigned to the Tarrant County Criminal District Court #3 but has not gone to trial. Brown was transferred to the John Peter Smith Hospital (JPSH) on October 6,

2022, for treatment of Metastatic Cancer. Dr. Akwaungo pronounced Brown deceased on Tuesday, November

8, 2022, at 9:40 pm in room P534 of JPSH. Detective Bennett is conducting the internal death investigation for

TCSO, report # 2022-16218. The Tarrant County Medical Examiner's Office (TCME) will be conducting an autopsy of Brown, report # 22-20321. The external agency investigation will be conducted by the Fort Worth Police Department (FWPD) Major Case Unit, supervised by Sgt. J. Phillips.
