# Summary of Incident

Summary of How the Death Occurred: (max. 30,000 characters)

#### Summary:

On December 6, 2022, the decedent was booked into the Harris County Jail with numerous medical conditions. While in jail, the decedent was transported to outside hospitals numerous times for his medical ailments. On January 10, 2023, while housed in a single-cell in the Infirmary, a medication nurse was unable to wake the decedent. Medical staff responded, started CPR, and transported the decedent to the clinic. Houston Fire Department paramedics arrived, assumed care, and transported the decedent to St Joseph Hospital. At 11:39 a.m., a medical doctor pronounced death.
