Summary of Incident

Summary of How the Death Occurred: (max. 30,000 characters)

Summary:

On July 1, 2022, the decedent was arrested by HPD and booked into the Harris County Jail on an open felony warrant for Continuous Sexual Abuse of a Child. On January 31, 2023, inmates alerted jail staff, the decedent was experiencing a medical emergency in his bunk. Officers arrived and noted the decedent was responsive, and medical staff arrived. Upon transport to the clinic, the decedent became unresponsive and chest compressions began. Life-saving measures continued in the clinic, where care was transferred to arriving HFD paramedics. HFD transported the decedent to Ben Taub Hospital where he was pronounced deceased by a medical doctor.
