Summary:

On 03/12/2023 at approx 0335am hrs White Oak Police Officer observed vehicle heading west on Hwy 80 @ Hwy 42 traveling on a flat left front tire. Vehicle made a U-turn in the intersection and headed East on Hwy 80. White Oak Officer Activated his Red/blue overhead lights and siren and the suspect vehicle refused to stop. The vehicle traveled into the city of Longview and came to a stop at Loop 281 and Hwy 31. Before the vehicle came to complete stop the suspect opened the driver's door and displayed a handgun and shot several rounds in unknown direction. The suspect, later Identified as Danny Jackson exited the vehicle with the handgun and fled on foot to the parking lot on the North side of Hwy 31 (1715 SH-31 W, Longview Texas). where he turned and pointed the firearm toward the pursuing officers. White Oak Police, Texas Department Public Safety and Longview Police officers fired at Jackson at this time sticking him twice. Jackson was given first aid and once LFD arrived Jackson was transported to Good Shepherd Medical Center in Longview where he succumbed to his injuries pronounced deceased by JP 2 Tim Bryan at 145pm.
