# Summary of Incident

Summary of How the Death Occurred: (max. 30,000 characters)

#### Summary:

On March 21, 2023, the decedent was booked into the Harris County Jail and escorted to the second floor during the booking process. While on the second floor, the decedent entered a restroom stall. An inmate notified staff, an inmate had been in the restroom for an extended length of time. An officer unlocked the door and entered. The decedent was found unresponsive with a drawstring from his jacket around his neck and lower extremities. CPR was immediately started, and medical staff arrived. Life-saving measures continued in the clinic, and Houston Fire Department paramedics arrived. The decedent was transported by paramedics to St Joseph Hospital where he was pronounced deceased by a medical doctor.
