Summary:

On May 2, 2024, the decedent was arrested and booked into the Harris County Jail with a history of numerous medical and mental health problems. The decedent was housed in the Mental Health Unit and Medical Infirmary. On July 17, 2024, while medical staff was at the decedent's cell, the decedent suffered a medical emergency. Medical staff started CPR and transported the decedent to the clinic. A pulse was regained, and the Houston Fire Department (HFD) was called. The decedent lost her pulse as HFD personnel arrived and life-saving measures resumed. The decedent was transported to Ben Taub Hospital where her care was released to hospital staff. At 11:43 p.m., a medical doctor pronounced death.
