but would not step out of the vehicle. The officers had the driver's door open as they attempted to interview him. When the officers asked the driver about his vehicle and license plates, he immediately became irate, started the ignition, and then tried to put it into gear. Both officers reacted by reaching inside to try to prevent him from putting the vehicle in reverse, but were unsuccessful. The subject revved the engine and started reversing the SUV while also dragging the officers. The subject continued backing up and ignoring the officers' commands to stop, Officer Lopez drew his service weapon and fired one shot into the subject's upper torso. The subject then put the vehicle into DRIVE and raced through the parking aisle towards the front of the store, throwing the officers from the moving vehicle. At some point, the subject lost consciousness and the vehicle then crashed into the front concrete wall of the store. The officers ran to the vehicle and discovered the subject to be unresponsive. Fire Medical Services were requested to the scene, but did not transport the subject as he was obviously deceased.
