## Summary of Incident

Summary of How the Death Occurred: (max. 30,000 characters)

Summary:

On 3/31/20, Austin Police officers responded to a Trespass Urgent 911 call. The call text stated the father of the complainant's children was at her residence acting strange and refusing to leave. Officers arrived at the scene and spoke to the complainant outside of her residence. Officers then contacted the subject inside the residence refusing to leave. While speaking with the subject, officers confirmed with Austin Police communications that the subject had been given a previous criminal trespass warning by officers for the same

residence on March 6th, 2020. Officers continued to speak to the subject while he attempted to provide proof that the complainant had invited him over to the residence. The subject was not able to provide any evidence or proof via his phone to officers. Officers gave verbal commands to the subject as they went to place him under arrest for criminal trespassing. The subject refused to obey the verbal commands and began to resist officer's attempt to place him in handcuffs and under arrest. As the subject began to resist, officers disengaged with their hands, backed away, with one of the officers drawing his Taser. This officer had observed the subject was a large man, approximately 6'0" tall and over 300lbs. The officer with the Taser, continued to verbally give the subject commands but the subject did not comply. The officer deployed his Taser and the subject quickly got down on the floor. The officers again attempted to place the subject into handcuffs, but the Taser did not cause neuromuscular incapacitation. The subject continued to physically resist and began to actively attempt to exit the apartment by physical force. After a prolonged physical struggle between the officers and the subject, he was placed into handcuffs. Once the subject was in handcuffs, he continued to be non-compliant. During this time, additional Austin Police officers arrived to assist, and officers called for Emergency Medical Services (EMS). Once EMS arrived at the residence, the Officers asked the subject to stand up and walk down the stairs. The subject did not comply causing the officers to have to physically help him down the stairs. The subject was transported from the bottom of the stairs to the EMS stretcher. While the subject was in the EMS unit and still at the scene of the incident, he became un-responsive and EMS personnel began CPR. The subject was transported by EMS to South Austin Medical Center where the subject was pronounced deceased by Dr. Pena at 17:05pm.
